Except for Goods that Buyer has agreed to recondition, Seller expressly warrants that the Goods are not subject to any label-change or tag-removal requirements, or the like, and Seller expressly authorizes Buyer to resell the Goods in the condition in which the Goods are delivered to Buyer by Seller. Seller shall maintain a quality assurance program for the Goods that meet best industry standards. Seller expressly warrants and represents to Buyer that (i) Seller is in full and absolute compliance with any and all legal and/or regulatory requirements and guidelines relating to the Goods, including, without limitation, all issues relating to: advertising, labeling, packaging, manufacture, delivery and sale; (ii) the Goods will be free from material defects, merchantable, and fit for their intended use including human consumption; (iii) Seller and the Goods (including all content of the label) are in compliance with all applicable federal, state, local laws, rules, and regulations applicable to the Goods, including, without limitation, all laws regarding product safety laws, export control, unfair competition, false advertising, and hazardous waste or toxic substances shipping, management, handling or disposal laws, California's Proposition 65, the Consumer Product Safety Improvement Act of 2008, as may be amended ("CPSIA"), and the U.S. Federal Food, Drug and Cosmetic Act (the "Act"); (iv) the Goods will not be adulterated or misbranded within the meaning of the Act, and were manufactured, produced, stored and/or delivered in accordance with appropriate current good manufacturing practices as set forth in U.S. Code of Federal Regulations, Title 21, Part 117; (v) no Goods will contain hazardous substances including heavy metals and toxic substances or, if such materials are present, they will either be present at or below the applicable safe harbor levels established by California's Proposition 65 or Buyer will include a Proposition 65-compliant warning on the Goods' label; (vi) Seller will be in full compliance with all certification, testing, and other requirements under applicable laws, rules, or regulations, including without limitation testing and certification of Goods under the CPSIA; and (vii) Seller is the "producer" or the "manufacturer" under all extended producer responsibility laws, including, but not limited to the Oregon Plastic Pollution and Recycling Modernization Act and the California Plastic Pollution Prevention and Packaging Producer Responsibility Act, for all products subject to this purchase order and is responsible for compliance with those laws, including by registering with a product responsibility organization and reporting all products subject to this purchase order as applicable. Seller shall defend, indemnify and hold harmless Buyer and its parent, subsidiary, or other related or affiliated entities from and against any lawsuit, claim or demand of any kind or nature whatsoever, arising as a result of or in connection with the Goods sold under this agreement or the terms of the Purchase Order. Grocery Outlet Inc. must be named as an additional insured on your general liability insurance policy. No backorders will be accepted without prior approval.
