This inter alia includes, but is not limited to:


- Sufficient and trained staff, with adequate level of qualification;

- Finished product meeting defined acceptance criteria which storage, release, shipment and returns did not alter, as well as supportive checks and documentation;
- Quality control laboratory sampling and testing records of raw materials and final products preventing release if not meeting the set quality requirements;
- Complaints and recalls review, investigation, and follow-up.
