Terms and Conditions 条款与条件

1. Delivery Date: The goods should be ready on or before the delivery date above.
 Pickup Location: 5 Argonaut, Aliso Viejo, California 92656

2. Quality Guarantee: Supplier shall keep quality control on all the goods. If any quality issues occur, then Supplier shall full refund and bear all the extra cost incurred including the marketing fee.
 质量保证: 卖方需要确保货物的质量。如有质量问题, 卖方需要全额退款同时承担因质量问题导致的所有费用包括市场推广费。

3. Packaging: the packages shall be suitable for long distance transportation and resistant to dampness, moisture, shock, rust and rough handling; pallets shall be marked with weight, quantity and name of products, name of consignee, name of manufacturer and other related information. If wooden packings (including wooden boxes, wooden splints, stow-wood and crosser) are needed for packaging, the Supplier shall ensure that all wooden pallets are stamped with standard mark of "IPPC" and provide Inspection Certificate of Fumigation to indicate that it complies with the international rules with respect to plant protection. If Goods are transported via sea freight, the Supplier shall ensure that the height of pallets cannot exceed 1.8m, otherwise all the additional expenses incurred shall be borne by the Supplier.

Any additional costs (including not limited to container charges, delayed declaration charges, detention charges, demurrage charges and/or administrative penalties) incurred to the Purchaser caused by the failure of the Supplier to properly provide the stated documentation on time shall be borne by the Supplier.
