### Wholesale Terms and Conditions- accompaniment to order confirmations below

1. Customer purchase orders for Jonathan Simkhai products shall be deemed to become a final binding order only upon Jonathan Simkhai transmission of this written/digital order confirmation, and the final terms of the order shall be deemed to be as stated in Jonathan Simkhai order confirmation. Including all terms of the order confirmation establishing the terms of shipping and payment. Terms of the order can be edited by Jonathan Simkhai at any point prior to delivery without prior notice.
2. Customer may not cancel or change any final binding order. If the Customer fails to pay for or take delivery of any portion of the accepted order or cancels its purchase order for some or all of the Jonathan Simkhai products, Jonathan Simkhai may attempt to resell said cancelled Jonathan Simkhai products and the Customer shall pay Jonathan Simkhai the difference between the customers purchase order price for the cancelled Jonathan Simkhai products and the price at which Jonathan Simkhai is able to resell, plus Jonathan Simkhai costs of reselling (which amount is collectively the "Reselling Loss"). Customer shall pay Jonathan Simkhai the Reselling Loss immediately upon invoicing from Jonathan Simkhai or, at its option Jonathan Simkhai may credit any deposit monies for unshipped goods towards the Reselling Loss. Jonathan Simkhai shall bear no obligation to refund any deposit monies should Customer not take delivery of any/all Jonathan Simkhai products. Jonathan Simkhai may, at any time, in its sole discretion, discontinue or limit the production or sale of or modify the design or material specifications of any Jonathan Simkhai product without any liability or obligation to Customer. If shortages of Jonathan Simkhai products occur because of economic, manufacturing, or other conditions including shortages of materials or high demand for Jonathan Simkhai products, Jonathan Simkhai may allocate its Jonathan Simkhai products amongst its Customers, on any basis at Jonathan Simkhai sole discretion. Jonathan Simkhai shall have no liability to Customer by virtue of any such shortage or allocation.
4. Any provision contained in any purchase order issued by Customer to Jonathan Simkhai which is inconsistent or conflicting with any provision in the order confirmation or is inconsistent or conflicting with, or in addition to, any of Jonathan Simkhai then current standard terms and conditions of sale, shall not be binding unless Jonathan specifically and expressly assents to such provision in a separate writing signed by the authorized representatives of both parties and state on its face the intention to modify certain specifically identified terms which must be set forth in the writing.
5. All completion dates are ex-works, and if the completion date of a shipping window stated on the order confirmation happens to fall on a holiday or weekend the completion date would be the following business day. So long as Jonathan Simkhai notifies the Customer of ready goods within the shipping window, the order is deemed to be on-time. Should the Customer be silent to the ready goods notifications Jonathan Simkhai may, at any time, and its sole discretion reallocate the ready goods to other Customers and bears no obligation to refund any deposit monies.
6. Customers with Net payment terms are granted such terms contingent on factor approval at the time of shipment.

7. Prices shall be in US Dollars or Euros and Customer shall make payments in US Dollars or Euros in accordance with the prices confirmed on the order confirmation. All orders ship from either Los Angeles, CA, the Netherlands, Hong Kong or Canada depending on the Customers location.
8. For all international Customers and new domestic Customers, unless otherwise stated in the order confirmation's terms, all orders require an advance, non-refundable, 30% deposit, which will be due within ten (10) business days after written order confirmation from Jonathan. The parties expressly disclaim and exclude the applicability of the UN Convention on Contracts for the International Sale of Goods (1980). Venue for any action or proceeding arising out of or relating in any way to this Order, or the business relationship between Jonathan and Customer, shall lie in Los Angeles County to the exclusion of all others. 
