In the case of crustaceans:

The crustaceans originate from an establishment with no reported cases of white spot disease (WSSV), crayfish plague (Aphanomyces astaci), infection with yellow head virus genotype 1 (YHV1), infectious hypodermal and hematopoietic necrosis (IHHN), infectious myonecrosis (IMNV), necrotizing hepatopancreatitis (Hepatobacter penaei), Taura syndrome (TSV), white tail disease (Macrobrachium rosenbergii nodavirus), and acute hepatopancreatic necrosis (AHPND) within 60 days prior to export.
