A 50% deposit is required on all orders, and payment by the Purchaser (as listed in the Sold To section of this Sales Order) constitutes agreement to all Ebanista terms. The Purchaser confirms that the name on the payment method matches the Sold To section and assumes responsibility for all payments. All sales are final. No cancellations, returns, or refunds. Ebanista does not guarantee any specific delivery date on any merchandise. Delivery dates are estimates only. This agreement supersedes any verbal or written contradictions. Ebanista offers a limited warranty against any manufacturing defect for a period of one year after delivery. All merchandise sold from the showroom floor is sold on an "asis" basis with all faults. All orders are subject to correction and approval by the corporate office before they are accepted. In the event of any corrections or price adjustments, Ebanista will notify the Purchaser of any possible adjustment and will hold the Purchaser's order pending Purchaser's written confirmation and acceptance of any adjustments. Due to the handmade nature of Ebanista products, variations in dye lots, finishes, textures, colors, sizes, and materials are expected. Ebanista does not guarantee any exact dimensioning on any merchandise. Ebanista does not guarantee any fabric or leather against wearing, shrinking, colorfastness, fading, and/or oxidizing, color matching, or dye lot variation. Upholstery fabric application is at Ebanista's discretion unless otherwise specified. COM pricing and yardage requirements assume 54" plain goods unless otherwise specified; special handling may require additional yardage or fees. Due to the inherent qualities of velvet, mohair and/or other fabrics constructed with a short, dense pile, Ebanista cannot be responsible for any markings, creases, and/or pressure points that may occur in shipping or with use after delivery. Ebanista will notify Purchaser when merchandise is ready for delivery. The balance is due within ten business days of said notification, and once payment in full is received, goods will be released for delivery on next available truck scheduled for Purchaser's ship to address. If Purchaser does not pay balance due within thirty days, Ebanista may retain goods and forfeit the deposit as liquidated damages. If Purchaser does not agree to delivery date within thirty days of payment in full, Ebanista may elect to store the merchandise at the Purchaser's expense. Delivery is performed by Regal Designer Delivery and associated parties. Regal Designer Delivery does not accept deliveries "subject to inspection." Damages or discrepancies must be noted on the bill of lading and signed at the time of delivery. Failure to do so releases Regal Designer Delivery from liability. Signing without notations confirms receipt "free and clear." Regal Designer Delivery's liability is limited to sixty cents per pound per article unless a higher declared value is requested (subject to extra charges). No liability is accepted for concealed damage in crated/cartoned items. Reimbursement/replacement is at Regal Designer Delivery's discretion. Purchaser must complete a Delivery Information form on this Sales Order, and any changes without prior notification may incur additional charges or rescheduling fees. Incorrect information causing a failed delivery results in a second delivery charge. Purchaser is responsible for ensuring that the delivery location is accessible. This includes verifying that items can be safely delivered through doorways, stairways, elevators, and any other areas leading to the designated room. Any restrictions or obstacles must be communicated in advance to avoid delays or additional charges. Delivery service includes unpacking uncrated items, inspection, and placement. Assembly of beds is included. Crated items will have one side of the crate removed for inspection. Full uncrating and crate removal requires additional fee. Delivery fees are non-refundable. Title to goods remains with Ebanista until fully paid. Purchaser assumes responsibility for proper installation. Ebanista is not liable for improper installation or misuse. Any disputes must be resolved via binding arbitration in Orange County, California. Litigation rights are waived. California law applies. Arbitration costs are shared equally, and the prevailing party is entitled to attorney's fees and costs.
