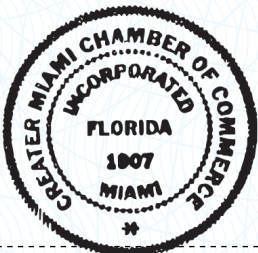

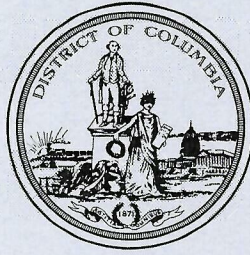

We, LAM USA INTERNATIONAL TRANSPORT LLC, hereby confirm the following regarding the shipment from the United States of America to Türkiye under:

During the unloading at the port of arrival in Türkiye, it was determined that the actual number of packages (cartons) is 1211, whereas the bill of lading incorrectly stated 7790 packages.

We hereby confirm that:

- The correct number of packages (cartons) loaded and shipped is 1211.
- The figure 7790 refers to the quantity of items inside the cartons and was mistakenly declared as the total number of packages in the bill of lading.

Accordingly:

1. A clerical error occurred in the bill of lading regarding the number of packages.
2. The actual number of packages loaded at the port of origin in the United States is 1211.
3. No additional packages were loaded.
4. There is no physical shortage, and the discrepancy is solely due to a documentation error.

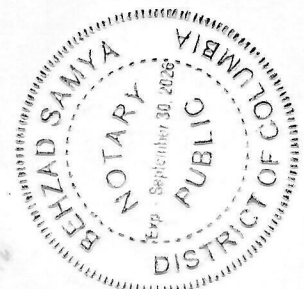
