II. Terms of Service

1. Third Party Agent Status

- (a) Shipall is a freight forwarder handling exports from the United States to international destinations, is bonded, licensed, and insured, and follows all regulations of US federal agencies.
- (b) Any business transacted unto Shipall is with the understanding that Shipall acts as an agent only, and furthermore that Shipall has no direct control over export schedules, loading decisions from the shipping lines, or clearance from US Customs.

2. Rates and Fees

- (a) Rates quoted by Shipall are dependent on the information provided by Shipper. Any changes to this information may result in changes to the final rate.
- (b) Shipall's rate includes: ocean or air freight, bunker adjustment factor, US terminal handling fees, and US export documentation fees. All other services covered by Shipall's rate will be provided in writing. Any costs arising from services not provided in writing are the responsibility of Shipper.
- (c) Shipall's rate is only for services rendered in the United States. Shipall does not collect any fees due at overseas ports of destination, including, but not limited to: import fees, taxes, duties, port storage charges, and destination customs clearance. The applicable overseas shipping agents can provide more information on these fees.
- (d) Any fees, penalties, or costs imposed by US Customs, or occurring as a consequence of actions taken by US Customs, are the responsibility of Shipper, including any consequences related to the value of the commodities being shipped.
- (e) If delivery of goods to the port is made too early, or if delivery is attempted without proper documentation, shipments may be subject to fees, including, but not limited to: port storage, per diem fees, and roll-over fees. These fees will be the responsibility of Shipper, unless it is determined that these fees are a direct result of an error on Shipall's part. Shipall will not cover storage fees charged by the sellers of any items being shipped.
- (f) Shipper is responsible for any and all unpaid fees that arise from delays in claiming cargo at destination or abandonment of the shipment at destination.

3. Commodities

- (a) A general list of the items being shipped is required. A form will be provided to Shipper to gather the required information. For commercial shipments, a commercial invoice will suffice.

4. Insurance Claims

- (a) Shipall must be notified of any damage prior to the release of cargo from the destination port. Any claims related to damages of shipments must be filed directly with the particular shipping line that carried Shipper's cargo. For Shipall to assist in insurance claims, it is mandatory that an insurance claim be fully filed prior to releasing the cargo at the overseas port.
