Any business that has moved to a new location within the city limits should contact the Community Development Department at 805-388-5360 for information on getting the new location approved.

The city will mail a renewal notice to the mailing address on file; however, it is your responsibility as the business owner to pay the business taxes when due to avoid penalties. Penalties are assessed for delinquent accounts, regardless of whether you receive a renewal notice or not. If you do not receive a renewal notice by the expiration date of the tax certificate, please contact the Business Tax Division immediately.
