Account Information and Requirements

The taxes you are required to report annually are identified above. Tax reports must be filed timely, even if there is no business activity or if the first year in business is less than 12 months. You are obligated to pay timely and file tax returns until you formally dissolve your corporate charter, file an out-of-existence affidavit or cancel a license or authorization. Failure to file and pay timely may result in penalties and liens. For information on tax due dates, visit the department's website at **www.revenue.pa.gov**.

Pay particular attention to the month your tax year ends, identified above, for the following reasons:

- For corporate net income and mutual thrift taxes, the first quarterly estimated payments are due within 75 days following the incorporation/certificate of authority date.
- A federal subchapter S corporation desiring not to be taxed as a PA S corporation is required to file REV-976, Election Not to be Taxed as a Pennsylvania S corporation, on or before the due date or extended due date of the first tax period for which it is to be in effect. REV-976 is available at **www.revenue.pa.gov**.

SUBJECTIVITY TO CORPORATE TAXES FOR LIMITED LIABILITY COMPANIES AND BUSINESS TRUSTS

- Under Section 601 of the Tax Reform Code, limited liability companies and business trusts are considered corporations for purposes of capital stock/foreign franchise tax, regardless of how they file with the Internal Revenue Service (IRS).
- Under Section 401 of the Tax Reform Code, any entity that files as a corporation with the IRS is subject to PA corporate net income tax. A limited liability company or business trust that does not file as a corporation with the IRS is not subject to the PA corporate net income tax.

Electronic Filing

All payments of \$1,000 or more must be remitted electronically or by certified or cashier's check remitted in person or by express mail courier. Taxpayers can make electronic funds transfer (EFT) payments by registering at **www.etides.state.pa.us** or by calling TeleFile at 1-800-748-8299. For assistance, call 717-783-6277.
