## **OPERATIONAL CONDITIONS OF APPROVAL**

This Business License is granted to the business ("Business") named above. By continuing to operate a business in the City of Cerritos, the Business agrees to abide by the following operational conditions of approval:

1. Business operations shall be conducted in accordance with the approved application, supplemental documentation submitted by the applicant, and other Conditions of Approval required by the City.
2. The Business License and all related Conditions of Approval shall be subject to review and amendment on an annual basis upon request for renewal by the Business.
3. No changes to the Business operations, including the expansion of leased area, shall be conducted without prior written approval of the City of Cerritos.
4. No alterations or improvements shall be made to the subject property, including signs, exterior painting, interior partitions and fixtures, storage racks, landscape, outdoor furniture, or other improvements, without prior Planning approval and/or building permit(s) issued by the City of Cerritos.
5. The property shall be maintained at all times in compliance with Property Maintenance requirements of Cerritos Municipal Code (CMC) Chapter 6.22 and with the Zoning/Development requirements of CMC Title 22 applicable to the zone in which the subject property is located.
6. Any change in federal, state, or local laws governing the use, occupancy, or operation of the Business shall be cause for review of the Business License and possible amendment to the terms and conditions under which the Business License is approved.
7. The Business agrees to indemnify, defend, and hold harmless the City of Cerritos and its officials, officers, employees, and agents, from any claim, action, or proceeding to challenge, set aside, void, or annul the approval of this license or operations of the Business pursuant thereto.
8. With respect to the foregoing Condition of Approval, the City will have sole discretion to approve any defense counsel. The City will notify the Business promptly of any such claim, action, or proceeding, and will cooperate with the Business in any defense required by said Condition of Approval.
