NOTIFICATION OF POTENTIALLY APPLICABLE CODES AND ORDINANCES

COMMERCIAL AND INDUSTRIAL BUSINESS LICENSES

The Planning Director finds that the following codes and ordinances are required or authorized by law. The conditions are imposed pursuant to the Sacramento County Code (SCC), the Sacramento Zoning Code (SJC), the California Penal Code (CPC), or the California Vehicle Code (CVC). Please be aware that the conditions listed below may apply to your business operations, and those codes and ordinances applicable to your business must be implemented.

SIGN REGULATIONS

1. There shall be no inflatable/portable/A-Frame signs or feather flags. (SJC 5.10.1.I.8, 5.10.1.I.15, 5.10.1.I.16.)
2. There shall be no outdoor display banners, flags or pennants, unless authorized pursuant to a Temporary Use Permit. (SJC 5.10.1.I.17, 5.10.1.J.)
3. Signs should be posted around the premises stating: "NO TRESPASSING." (CPC 602 (k).)
4. Signs should be posted around the premises stating: "NO OVERNIGHT TRUCK /RV PARKING." (CVC 22658.)

PUBLIC NUISANCES

1. Comply with the Sacramento County Noise Control ordinance. (SJC 5.5.2.D.2; SCC 6.68.)
2. Any condition recognized in law or equity as constituting a public nuisance is prohibited. (SCC 16.18.401 (X).)
3. Use of the property for outdoor expositions, concerts, events, or similar activities is prohibited, unless specifically allowed as a promotional display. The Zoning Administrator may approve a temporary use permit to allow the use of the property for a period not to exceed 10 days within a given year for these activities. (SJC 3.10.2.L.)
4. There shall be no loitering on or around the premises in such a manner as to:
 - a. Create or cause to be created a danger of a breach of the peace.
 - b. Create or cause to be created any disturbance or annoyance to the comfort and repose of any person.
 - c. Obstruct the free passage of pedestrians or vehicles.
 - d. Remain upon any business premises after its business hours, without the consent of the owner or legal occupant.
 - e. Remain upon any private property without the consent of the owner or legal occupant.

- f. Remain upon any business premises or private property after having been asked to leave by the owner or legal occupant.
- g. Remain on any property in the proximity of any posted no-cruising zone between the hours of 6:00 p.m. of one day and 6:00 a.m. of the next day. (SCC 9.82.020.)

DEVELOPMENT STANDARDS

1. All graffiti shall be removed within a reasonable time. (SCC 6.120.030.)
2. Any third party vendors operating outdoor temporary concessions require separate use permits. (SAC 3.10.2.L, 3.10.3.E.)
3. Any device, sign, or fence which is visible from the public right-of-way or neighboring properties and which is kept in a state of disrepair or creates a health or safety hazard is prohibited. (SCC 16.18.401 (G).)
4. All trash and recycling containers and enclosures shall be located within an enclosed masonry area, with an appropriate solid gate. (SAC 5.5.2.D.1.)
5. Comply with the Sacramento County Hazardous Materials Business Plans and Hazardous Waste Generators ordinances. (SCC 6.96, SCC 6.98.)
6. Parking lot lighting shall meet the standards of SAC 5.9.4.G, including measures to reduce light trespass to adjoining properties. No light fixture shall directly illuminate an area outside of the site, and the light source shall not be visible from residential properties. (SAC 5.9.4.G.)
7. In any zoning district except an industrial zoning district, no equipment, material, goods, furniture, or appliances may be stored or displayed outside an enclosed building or outside of a solid screen fenced area and be visible from a public street, unless that equipment, material, good, furniture, or appliance is normally used out of doors. No equipment or goods may be displayed within required yard areas unless located within the buildable portion of the lot. Display of new goods is allowed with a setback of 25 feet upon issuance of a minor use permit. (SAC 3.9.3.J.)
8. Any accumulation of junk, rubbish, abandoned, neglected or broken equipment or machinery, furniture, containers, packing materials, or scrap wood which is visible by persons on adjacent or nearby real property or the public right-of-way and which constitutes visual blight, reduces the aesthetic appearance of the neighborhood, is offensive to the senses, or is detrimental to nearby property or property values, is prohibited. (SCC 16.18.401 (A).)
9. Landscaping must comply with the Landscape Standards found in SAC 5.2.4.
10. Failure to address the following below is a nuisance as detailed in SCC 16.18.401 (C) (2) (3), (4) & (5) :
 - a. Regularly maintain plant material, including, but not limited to, irrigating, mowing and trimming in a manner consistent with applicable Sacramento County Code requirements; or
 - b. Keep irrigation systems in proper working order to provide water and coverage that is consistent with applicable Sacramento County Code requirements; or
 - c. Remove and/or replace any overgrown, damaged, dead, diseased, or decaying plant materials likely to harbor vectors; or
 - d. Comply with applicable County landscaping design plan and permit requirements and development permit requirements for landscaping.
